KAU-Reconstitution of the XVI th General Council- Bye Election under Section 10 Elected members sub-clauses (3) (4) & (6) of KAU Act (Act 33 of 1971 as amended vide Act 16 of 2001) – Bye Election Notification published.

Whereas it has become expedient to reconstitute the General Council of Kerala Agricultural University, it is hereby notified that a Bye election will be held to the General Council according to the principles of proportional representation by means of single transferable vote and as per provisions contained in Statute SRO No. 678/74 in the following constituencies

1	Teachers of the University	1(One)
2	Students of the University	1(One)
3	Permanent Labourers of the University	1(One)

Details of Polling Stations, Polling areas, Electoral Roll Numbers of electors to vote at the station etc. will be published.

Only those whose names have been included in the electoral roll as published by the University on 23.11.2016 and corrections issued up to 08.12.2016 are eligible to take part in the Bye election and vote thereof, provided that any person who ceases to be a member of the electoral body before the date of poll shall not be entitled to participate in the Bye election.


Copies of the electoral rolls can be had from the University office on payment of Rs.10/- per copy. Every elector is at liberty to nominate a duly qualified person who is a member of the constituency concerned. Every nomination shall be in writing and shall be seconded in writing by another elector Nomination should be made in prescribed form, copies of which will be supplied on request from the office of the Registrar & Returning Officer.

The envelope containing nomination paper shall be super scribed “Nomination for Bye election to the General Council from the Constituency of

The Candidate and one nominee authorized by the candidate in writing with the approval of the Returning Officer can be present at the venue of scrutiny of nomination.

Programme for the conduct of Bye Election

Last date and time for receipt of nominations is on 11.01.2017 at 04.00 PM .Time and date of scrutiny of nomination is at 11.00 AM on 13.01.2017. Date of publication of the list of the candidates validly nominated is on 13.01.2017. Last date and hour for the withdrawal of Candidature is on 18.01.2017 at 4.00.PM. Date of publication of the final list of contesting candidates is on 19.01.2017. Date and hour of poll is on 15.02.2017 from 9.AM to 1 PM. Date and hour for scrutiny and counting of votes is on 17.02.2017 at 10.AM. Declaration of results is on 17.02.2017. Date of publication of the results in the University office and date of effect is on 22.02.2017.
