In exercise of the powers conferred under sub-section 2(b) of Section 12 of the Kerala Agricultural University Act (Act 33 of 1971) the General Council of the Kerala Agricultural University has been pleased to issue the amendments to statute for the faculty of Forestry issued as per Notification No. GA/E3/8394/2010(i) dated 01/04/2012 as assented to by the Chancellor with effect from 20/09/2022 under section 49 (6) of the said Act.

AMENDMENTS

That in the first paragraph of the said Notification the 'First Statutes' may be substituted by 'Fresh Statutes'

Explanatory Note

(This does not form part of the notification but is intended to indicate its general purport.)

Section 49 of the Kerala Agricultural University Act, 1971 (Act 33 of 1971) provides that the Statutes of the University shall be made by the General Council. As per the provisions of the KAU Act, University is not competent to make 'first statute' as the power is vested with the Government and the same has been already issued by the Government in the case of faculty of Agriculture. The Secretary to Government, Agriculture (Farms) Department has pointed out the same vide letter No.29124/AF2/2011/AD dated 8.3.2012 and informed the first statute & first ordinances of the University shall be made by the Government. University is competent to make amendment to the first statute issued vide SRO No.447/72 as well as to issue fresh statute (no first statute) invoking clause (i) of section 48of the Act following the procedure provided in section 49 of the Act. This statute has been framed by amending the existing statute for the faculty of Forestry issued as per Notification No. GA/E3/8394/2010(i) dated 1/04/2012. This notification is intended to achieve the above object.
