The cost of tender form of Rs.400/- and GST of Rs.72/- will be accepted by way of separate Demand Draft drawn in favour of "Associate Director of Research, Regional Agricultural Research Station, Pattambi "payable at State Bank of India, Pattambi and should be send separately with the tender.
- EMD amount of Rs.1500/- should be remitted along with the tender cost, by separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi, payable at State Bank of India, Pattambi.
- Tender cost and EMD can be paid by cash directly at RARS office during office working hours.

drawn in favour of Associate Director of Research, Pattambi payable at State Bank of India, Pattambi.
