- EMD amount of Rs. 1% of the amount quoted subject to minimum of Rs. 1500/- should be remitted along with the tender cost, by separate Demand Drafts drawn in favour of Associate Director of Research, Regional Agricultural Research Station, Pattambi, payable at State Bank of India, Pattambi.

- The item should be supplied in accordance with the supply order issued from this office and installed accordingly.
- 10. Payment of cost of the materials will be made by invoice cum cheque basis.
- 11. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture of EMD/Security Deposit.
