1. Bid documents including the Bill of Quantities (BoQ) can be downloaded free of cost from the e- Government Procurement (c-GP) Website www.etenders.kerala.gov.in. All bid documents are to be submitted online only and in the designated cover(s)/ envelope(s) on the e-GP website. Tenders/ bids shall be accepted only through online mode on the e-GP website and no manual submission of the same shall be entertained. A bid submission fee and EMD shall be remitted online during the time of bid submission.
2. Bidders should download the BoQ , Preliminary agreement, NIT and Tender documents from e - tender website. The proposed item-wise rate should be recorded in the Item wise BoQ and uploaded in the e-tender site.
3. Scanned Documents to be submitted online:
 - a. Tender form: The terms and conditions should be read carefully and all pages of the tender document should be signed by the bidder
 - b. Duly filled and signed preliminary agreement of the bid executed in Kerala stamp paper worth Its,2001-,(Bids received online without the scanned copy of preliminary agreement will not be considered).
 - c. Copy of GST registration certificate. & PAN of the bidder.
 - d. Valid EMD exemption certificate from the Store Purchase Department, Govt. of Kerala or Udyog Aadhar Registration certificate, if the firm claims EMD Exemption.
 - e) Undertaking to the effect that the bidder is not debarred/ blacklisted or banned from any University/ Government Institute /PSU.
4. The bids shall be opened online at the office of The Dean, CoA, Padannakkad on 24.05.2025 at 2 .30 PM in the presence of the Bidders or their representatives who wish to attend. If the tender opening date happens to be on a holiday or non-working day due to any other valid reason, the tender opening process will be done on the next working day at same time and place,
5. Payment: Details required for e-payment (Details of bank account) shall be furnished along with the tender.

malfunction or breakdown of the electronic system while downloading or uploading the documents by the Bidder during the e-procurement process, All Government orders on tenders and any revision of taxes rates would be applicable to this tender

7. Bids which do not fully fill all or any of the conditions or incomplete in any respect are liable to be summarily rejected.

8. Withdrawal from the tender after having accepted or failure to supply these items within the specified time or according to specifications will entail cancellation of the order and attract legal procedures as per the agreement.

9. On receipt of purchase order, the supplier shall execute an agreement in Kerala stamp paper worth Rs. 200/- at own cost and furnish a Security of 5% of the total cost,

10. Rates quoted should be valid up to 31.03.2026 and should be inclusive of all charges such as packing, forwarding, freight, loading /unloading/handling and Government duties, if any.

11. , Advance payment will not be effected and payment will be made only after the satisfactory completion of the supply.

12. Any failure on the part of supplier in the fulfillment of contractual obligations will result in the forfeiture Security Deposit,

13. The Dean, College of Agriculture, Padannakkad has the right to accept or reject any or all tenders without assigning any reason thereof.
