Details of the requirement

Sample: **Rice (*Oryza sativa*)**; Number of samples: **12**; Genome size: **~430 Mb**; Requirement: **mRNA sequencing**; Read length: **PE 150 bp**; Number of reads: **30 million reads per sample (~ 9 GB data/sample)**

(RNA isolation, sample QC, library preparation, library QC, Sequencing (PE 150 bp, 30 M reads per sample), data output 9 GB per sample)

Bioinformatics analysis

FASTQ raw data files, Primary statistics report -QC, Read statistics, Reference genome IRGSP build 1.0 RAP-DB, alignment statistics report, transcript wise expression matrix across all samples-DESeq2, DEG reports (Log 2FC +/- 1), GO enrichment analysis, KEGG pathway enrichment analysis with separate reports for each significantly enriched pathway, Heatmap and clustering of expression profiles, Comparative DEG analyses for Control vs control, control vs stress, stress vs stress; Transcription factors among the DEGs, Identification of SSRs (EST-SSRs), detection of di to hexa nucleotide repeat motifs, SSR motif frequency and distribution analysis, annotation of SSR containing genes, SNP and inDel identification, manuscript support.

- Leaf samples will be provided for RNA isolation and sequencing
- The sequencing service provider must carry out both sequencing and basic downstream analysis as detailed above
- The raw data files and analysis reports must be submitted within 35 days from the date of receiving the samples.
- Payment will be processed only after the completion of sequencing and submission of data.
- Data must be delivered in a secure format.
