2. The sealed cover containing the tender should be superscribed "**Tender for the supply of chemicals**" should be addressed to the **Project Director & Head, ORARS, Kayamkulam, Alappuzha, Kerala-690 502**
3. Each tender should be accompanied by tender fee and an Earnest Money Deposit (EMD) of 1% of the total rupee equivalent cost of the quoted items (subject to minimum of Rs. 1500/-) by way of **two crossed Demand Drafts separately** for tender fee and EMD drawn in favour of **Project Director & Head, ORARS, Kayamkulam, Alappuzha, Kerala-690 502** payable at the State Bank of India, Kayamkulam (IFSC : SBIN0070078).
