- Regular updates and security enhancements during the subscription period.

1. The Tenders superscribed "Renewal of MyLOFT -the Remote Access Service Application" should be addressed to the Librarian, Kerala Agricultural University, Vellanikkara. The last date for the receipt of filled in Tenders is 5 pm on 25.02.2025 and the same will be opened at 11 pm on 27.02.2025 in the presence of tenderers or their authorized representatives who may be present at that time. The cost of tenders has to be remitted by means of DD or cheque drawn in the name of the Librarian, Kerala Agricultural University.

- Tender should be submitted in the prescribed form which can be downloaded from the website www.kau.in/tenders. The cost of the tender forms will not be refunded under any circumstances.
- 3. Each tender should be accompanied by an Earnest Money Deposit of 1% of the total quoted amount in the form of Demand Draft drawn in favour of Librarian, Kerala Agricultural University payable at SBI, Vellanikkara branch. The tender should be accompanied by an agreement in Kerala Stamp Paper worth Rs.200/- (Rupees Two Hundred only) and format can be downloaded from the above website. Withdrawal of tenders after its acceptance or failure to supply the items or supplies not in accordance with the specification will entail cancellation of the tender.
- 4. The successful tenderer should renew the MyLOFT for Kerala Agricultural University within five days from the date of the receipt of supply order. The Librarian, KAU reserves the right to remove the defaulted name from the list of suppliers permanently or for a specific period.
- 5. The successful tenderer should execute an agreement in Kerala Stamp Paper worth Rs.200/(Rupees Two Hundred only) and furnish a security deposit of 5% of the cost of the entire quantity of items quoted in the form of term deposit drawn in favour of The Librarian, Kerala Agricultural University, Vellanikkara. The format for the agreement can be downloaded from the KAU website.
- 6. The cost of the items quoted should be inclusive of all taxes and other applicable charges.
- 7. The rate shall be valid for a period of one year from the date of acceptance of tender.
- 8. The Librarian, Kerala Agricultural University reserves the right to accept or reject any or all of the offers without assigning any reason.
